# **Solidarity!**

On Monday, Oct 31, the Ford Government introduced legislation which not only curbed the rights of CUPE members, but threatened to eliminate free and fair collective bargaining in the province of Ontario.

CUPE members responded by staging a province wide protest, withdrawing their services and standing up for their Charter rights.

AMETFO joined CUPE members on their picket lines, and workers across the province resoundingly told the Ford government that their disregard for the rights and freedoms of Ontarians would not be tolerated.

On Monday, November 7, in the face of increasing protests and a looming general strike, the Government backed down and agreed to repeal Bill 28.

This is a significant win for CUPE, for all Unions, and for anyone who values the rights enshrined in the Canadian Charter of Rights and Freedoms. It is also a significant reminder of the importance and power of collective action.

## **Did You Know?**

Most AM ETFO members receive \$195 per year to use towards professional development. This money can be accessed for professional resources, some items of technology, to supplement the cost of a course to take, or to offset the cost of a supply teacher if a member took an absence for professional development. Each school gets an allotment based on FTE, and the total number of eligible members at each school. Cheques are sent in November from the local, and they should immediately get cashed into a separate "PD Fund" that is managed by a committee of ETFO members.
