Avon Maitland Teacher Local Bill 124 Remedy Arbitration Award

As part of the terms of the ETFO 2022-2026 Teacher/Occasional Teacher (T/OT) and Education Worker (EW) Central Agreements, ETFO and the government agreed that, in addition to the 1% annual increases negotiated during the 2019 round of bargaining, further compensation increases will be applied to ETFO salaries, wage schedules, daily occasional rates and applicable allowances ("wages") as follows:

- for September 1, 2019 to August 31, 2020 (Year 1): An additional 0.75% increase will be applied to wages (i.e., 1% + 0.75%);
- for September 1, 2020 to August 31, 2021 (Year 2): An additional 0.75% increase will be applied to wages (i.e., 1% + 0.75%); and
- for September 1, 2021 to August 31, 2022 (Year 3): Arbitrator Kaplan would determine the additional increase applied to wages. His decision identified this additional increase at 2.75% (i.e., 1% + 2.75%).

The Bill 124 remedy will be applied to the salary grids, wages and daily OT rates of all ETFO members retroactive to the 2019-20 school year, and it will result in permanent changes (increases) to members' salaries, wages and daily OT rates. These increases are also pensionable.
